

Delsey Luggage Countdown to the Caribbean Sweepstakes
OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1) SWEEPSTAKES PERIOD: The Delsey Luggage Countdown to the Caribbean Sweepstakes (the “Sweepstakes”) begins May 21, 2018, at noon Eastern Time (“ET”) and ends on June 21, 2018 at 11:59:59 PM PT (the “Sweepstakes Period”).

2) ELIGIBILITY: The Sweepstakes is open to permanent legal residents of the fifty (50) United States and the District of Columbia who are at least 21 years old at the time of entry. Void where prohibited. Employees, directors and officers, and their immediate families (spouse, parents, children, siblings, and their respective spouses), and their respective household members, of Sponsor, its affiliates, subsidiaries, divisions, advertising and promotion agencies and Prize Providers, are not eligible to enter or win. All interpretations of these Official Rules and decisions by Sponsor are final. “Household member” means people who share the same residence at least three months in a 12-month period.

3) SPONSOR: This Sweepstakes is sponsored by DELSEY Luggage, Inc., 6090 Dorsey Road, Suite C, Hanover, MD 21076 (the “Sponsor”).

4) HOW TO ENTER: During the Sweepstakes Period, visit <https://shop.delsey.com/Giveaway> (the “Website”) and follow the on-screen instructions to register by submitting your complete and accurate information, including first and last name, full mailing address, email address, and phone number, and answering several short questions to receive one entry into the Sweepstakes. There is a **limit of one entry per person, per email address, and per household** for the duration of the Sweepstakes Period. Entries received from any person, email address, or household in excess of the stated limitation will be void if discovered by Sponsor.

Any individual wishing to enter the Sweepstakes must follow all of the above instructions in order to be considered a valid entrant into the Sweepstakes (an “Entrant”). Should multiple users of the same email account enter the Sweepstakes and a dispute thereafter arise regarding the identity of the Entrant, the authorized account holder of said email account at the time of entry will be considered the Entrant. “Authorized account holder” is defined as the natural person who is assigned an email address by an Internet access provider, on-line service provider or other organization which is responsible for assigning email addresses or the domain associated with the submitted email address. Entrants may not enter more than the above stated limit using multiple email addresses, nor may Entrants use any other device or artifice to enter as multiple Entrants above the stated limit. Any Entrant who attempts to enter multiple times above the stated limit may be disqualified and forfeits any and all prizes won, if discovered by Sponsor and in Sponsor’s sole discretion. Automated entries are prohibited, and any use of automated devices will cause disqualification if discovered by Sponsor.

Use of Entrant Information: By entering the Sweepstakes, you acknowledge and agree that Sponsor will share your email address with the Prize Providers (defined below).

5) WINNER NOTIFICATION AND VERIFICATION: Receiving a prize is contingent upon compliance with these Official Rules. After the Sweepstakes Period, on or about June 22, 2018, one potential Grand Prize winner will be selected in a random drawing from all eligible entries received during the entire Sweepstakes Period. The drawing will be conducted by the Sponsor, whose decisions will be final and binding in all respects.

Sponsor will attempt to notify the potential Grand Prize winner via email and/or phone on or about June 25, 2018 and potential winner must respond within 48 hours of initial notification attempt. The potential Grand Prize winner will be sent an affidavit of eligibility/liability release, as well as a publicity release (where permitted by law) ("Release"). (TN residents need not sign the publicity portion of the Release.) The potential Grand Prize winner will be required to complete and return the Release within five (5) business days of when it is sent to winner.

If the potential Grand Prize winner: (i) does not respond within 48 hours after the initial notice is sent; (ii) fails to obtain all signatures on the Release and to return the documents and any required identification within five (5) business days; (iii) cannot accept or receive the prize for any reason; or (iv) is found not to be eligible or not in compliance with these Official Rules, the potential winner will forfeit the prize, and Sponsor will select an alternate winner in a random drawing from remaining eligible entries, time permitting.  - (b) The Vacation Package will be fulfilled in the form of a prize certificate outlining the terms and redemption procedures which shall be redeemable by filling in requested information and mailing back to the address indicated. The Grand Prize Winner must call the given telephone extension on the prize certificate to arrange the Vacation Package.
2. Round-trip, coach-class airfare for the Grand Prize winner and three (3) guests ("Guests") from a major commercial airport near the Grand Prize Winner's home to the designated airport near the selected Beaches Resort (airline, flight itinerary, and airport determined by Sponsor in its sole discretion), (ARV \$3,000);

Unique Travel, Corp., Beaches Resorts, Jack Rogers, Blue Planet Eyewear, and Laguna Beach Textile Company will be referred to collectively as the "Prize Providers." Actual value of the Sweepstakes Prize may vary depending upon airfare fluctuations and point of departure; any difference between stated ARV and final ARV will not be awarded. Sponsor and Prize Providers shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the air carriers, hotels, venue operators, transportation companies, Prize Providers or any other persons providing any Grand Prize-related services or accommodations. Sponsor will not replace any lost, mutilated, or stolen tickets, travel vouchers or certificates.

No substitutions or transfers of prize are permitted by the winner, except at the Sponsor's sole discretion. Sponsor may substitute prize of equal or greater value at its sole discretion. Prizes may not be sold, bartered or auctioned. If any portion of Grand Prize is unused (for example if less than four people take the trip) that portion of the prize will be forfeited and no alternate prize will be provided. The Grand Prize Winner will be issued an IRS 1099 form for the value of the Grand Prize, and will be required to provide Sponsor with his/her valid social security number or tax identification number before the Grand Prize will be awarded for tax reporting purposes. Properly claimed prize will be awarded, but in no event will Sponsor award more prizes than are provided for in these Official Rules.

8) RELEASE OF LIABILITY: Each Entrant irrevocably agrees (and agrees to confirm in writing) to waive, on behalf of themselves and their family and associated persons or businesses, all claims, lawsuits, and damages, of every name and nature, known and unknown, now existing or hereinafter at any time arising, against all other Entrants, and against Sponsor, Facebook, Instagram, Twitter, and Prize Providers, and each of their respective parents, affiliates, and subsidiaries, and all of their respective successors, assigns, officers, directors, agents, and employees and all others associated with the development and execution of this Sweepstakes from any and all liability, loss or damage with respect to or in any way arising from this Sweepstakes and/or acceptance or use of the prize, including liability for personal injury, death, damage, or monetary loss, and including any travel related thereto. Sponsor is not responsible for prize quality or utility. Sponsor is not responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error, which may occur in the processing of the entries. Sponsor is not responsible for computer system, phone line, hardware, software or program malfunctions, or other errors, failures or delays in computer transmissions or network connections that are human or technical in nature. Sponsor is not responsible for lost, late, stolen, incomplete, misdirected, damaged, destroyed or garbled entries.

9) PUBLICITY: Except where prohibited, participation in the Sweepstakes constitutes winner's consent to Sponsor's and its agents' use of winner's name, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, without limitation, worldwide, without further payment or consideration.

10) MODIFICATION OR TERMINATION: Sponsor reserves the right to modify or terminate the Sweepstakes upon evidence of fraud, virus, bugs, hacking, security breaches, or other tampering, or should other causes beyond the control of Sponsor corrupt the administration, security, or proper operation of the Sweepstakes. Sponsor also reserves the right to cancel, suspend, or modify the Sweepstakes, if necessary, due to technical problems. In the event of cancellation Sponsor shall have the right, at its sole discretion, to select winner by randomly drawing from among all valid, non-suspect entries received up to the time of cancellation. If Sponsor terminates the Sweepstakes, Sponsor will post notice on the Sweepstakes website. Sponsor reserves the right, at its sole discretion, to disqualify any individual (and his or her entry) who tampers with the entry process or the operation of the Sweepstakes, to be acting in violation of these Official Rules or to be acting in an unsportsmanlike or disruptive manner or in an annoying, abusive, threatening, or harassing manner. If a dispute arises regarding compliance with these Official Rules, Sponsor may consider, in its sole discretion, data reasonably available to Sponsor through information technology systems in Sponsor's control, but Sponsor will not be obligated to consider any data or other information collected from any other source.

11) IN CASE OF DISPUTE: By entering the Sweepstakes, entrants agree that: (a) any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes, or prize must be resolved individually, without resort to any form of class action; (b) any and all claims, judgments and awards will be limited to actual out-of-pocket costs incurred, including costs associated with entering the

Sweepstakes, but in no event attorneys' fees; and (c) under no circumstances will any entrant be permitted to obtain any award for, and entrant hereby waives all rights to claim punitive, incidental or consequential damages and any and all rights to have damages multiplied or otherwise increased and any other damages, other than for actual out-of-pocket expenses. Some jurisdictions do not allow for limitations on the ability to pursue class action remedies, or certain kinds of damages, and so these limitations may not apply to you. All issues and questions concerning the construction, validity, interpretation and enforceability of the Official Rules, or the rights and obligations of Entrant and Sponsor in connection with the Sweepstakes, will be governed by, and construed in accordance with, the laws of the State of Maryland, U.S.A., without giving effect to the conflict of laws rules thereof. If any provision of these Official Rules is determined to be invalid or otherwise unenforceable or illegal, these Official Rules will otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. If there is any discrepancy or inconsistency between any terms or conditions of these Official Rules and any disclosures or other statements contained in any other Sweepstakes-related materials, including but not limited to the Sweepstakes entry forms, or the point of sale, television, print, mobile or online advertising, the terms and conditions of these Official Rules will govern.

If you are selected as a winner, your information will be provided to the Prize Providers for fulfillment of each respective prize where applicable and will be included in a publicly available winners' list.
